In reference to the Court's letter of August 3 2010 where the Court indicates that I do not "...fulfil the conditions set out in Rule 36 §4 (a)", I would like to add the following information:

I am a Norwegian citizen residing in Luxembourg as a political and judicial refugee. As the President surly knows by now, I was forced out of Norway in 2006 by different governmental actions. These actions - which I am more than willing to prove before the President if so requested - are products of my engagement for the so called Riis-family, representing them in numerous cases against the Norwegian Government, both national as well as international.

My former client, Mr. Einar Riis Johannessen, was killed on May 30 2006, most likely by the same entity which fights me today. Ms. Anne Lise Sellæg, the late Mr. Johannessen's live-in partner/ mistress is still afraid of getting executed. In this regard, please find attached a transcript of a phone conversation of December 7 2007 in which she reveals her fears, as well as my letter of August 21 2010 to the Swedish Minister of Justice where I explain the graveness of the matter as well as my frustration over the fact that Swedish authorities are concealing a murder. As the President will understand, moving back to Norway is not an option for me.

There is obviously a need for lawyers fighting the corrupted officials and the corrupt political and judicial system in Norway in which these persons are working in. As I have no chance to even travel to Norway, in fear of my life, I am sure that the President of the Court will continue accepting me as a legal representative for those Norwegians seeking legal assistance they are deprived of in Norway.

Previous to this phone conversation I had summoned Ms. Sellæg as a witness in a hearing that was scheduled to take place on December 11 2007. In this regard Ms. Sellæg was to reveal information about her life with the late Mr. Einar Riis Johannessen and in particular about the last days with Mr. Johannessen, who died just a few days after they left for their cabin in Arvika, Sweden. Medical documents in this case prove that Mr. Johannessen was poisoned to death. One should also note that the head of the Norwegian Secret Service, which was also summoned, "escaped" as he told me in his email of December 10 2007 that he would instruct the judge to stay away from him.

For your information I am the Testamentary Executor of the estate of the late consul Einar Riis Johannessen.

I got quite surprised when I read about the actions against the head of Wikileaks in the Swedish newspaper www.expressen.se today. The article states that Mr. Julian Assange has been arrested in his absence accused of molestation and rape. I find it hard to believe that a man hunted by almost every warring western government finds time - in between his run - to rape some staff members or other volunteers. But that's beside the point here.

What is really troubling me now is the fact that the Swedish minister of justice as well as the Director General of the Swedish Public Prosecution for years has struggled their best to put a lid on the murder of the arms dealer, money launderer and aviation pioneer; consul Einar Riis Johannessen, instead of doing what they now to the full is doing in the case against Mr. Assange.

I will in short repeat some of the information the Swedish public prosecutor has been provided with: The late Mr. Johannessen was killed on May 30 2006, by rat-poison. Five days prior to his death, Mr. Johannessen and Ms. Anne Lise Sellæg, his mistress / live-in partner for 14 years, travelled to their cabin in Arvika, Sweden, preparing for a meeting in Skara. Ms. Sellæg was the last person – close to Mr. Johannessen – to see him alive. His wife, Amelia Riis, was allegedly in Monaco at the time of the poisoning.

Due to Mr. Johannessen's "adultery", his wife claimed that Ms. Sellæg owed her some NOK 10 million, the equivalence of some €1.2 million, for a ruined marriage. This claim was presented to Ms. Sellæg in 1997. On top of this the late Mr. Johannessen transferred – shortly after a € 7,5 million settlement I arranged with the Norwegian Minister of Justice – some NOK 4 million (approximately € 500.000) to Ms. Sellæg. Needless to say those two women were eternal enemies.

Amelia Riis stated numerous times, also in taped conversations, that she would claim the amount of NOK 14 million as soon as Mr. Johannessen was dead. A year after the murder Amelia Riis' claim had been put to rest, and Ms. Sellæg – Ms. Riis' previous enemy – had even been invited to an ash-throwing ceremony in Monaco. This indicates that Ms. Sellæg had been paid off; i.e. she could keep the money in return of keeping her mouth shut.

Furthermore the Swedish prosecutor has been informed that the certificate of death as well as the certificate of the cause of death has been forged by Swedish authorities (letter of July 19 2008 including evidence of forgery).

The late Mr. Johannessen, domiciled in Monaco, was (illegally) smuggled over the border to Norway, and cremated less than 70 hours after he was declared dead, actions which would have been impossible to carry out if the documents hadn't been forged. A notarised document called "A last whish" dated June 28 2000, signed by both Amelia Riis and Einar Riis Johannessen, states that none of them was to be cremated if there was the slightest doubt about their death. In this case medical documents reveal that the late Mr. Johannessen had been poisoned, not only once but at least five times during the course of less than one year. At least two (but most likely all) of these attempts contained deadly doses of poison, one in Monaco and one in Norway. Consequently there were more than enough reasons to not cremate the body of the late consul.

In this picture I will also remind you that Mr. Johannessen was a 50% owner of Aerolinee Itavia, once the second largest airliner in Italy. On June 27 1980 one of his aircrafts, Flight 870, was downed outside the shores of Ustica, hence the name Strage di Ustica (the Ustica massacre). It has been claimed that the aircraft had been used as a hideout for a French fighter plane on a NATO-mission waiting to down Mr. Muammar al-Gaddafi's aircraft travelling through this airspace at the time. Accidentally Flight 870 was hit by a missile launched from the French fighter plane after being spotted. The estate has initiated compensation actions against the French government, and the investigation of this massacre was reopened on June 23 2008.

Another disturbing fact is that Mr. Johannessen's son, Kenneth Patrizio Riis, was investigated for being accessory to arms dealing, furnishing a militant hideout, and terrorist activity in Italy. Shortly after Strage di Bologna (the Bologna massacre), Mr. Johannessen was warned by a high-rank (Arme dei) Carabinieri officer about an imminent razzia and the arrest of his son. The officer gave him just a few hours to ship his son out of Italy. His son was hence turned into a terrorist on the run. It took Mr. Johannessen some 12 years and considerable briberies in Italy to get his son into Italy again, with priceless help from the Norwegian Ministry of Foreign affairs.

There are thus plenty of aspects here for several governments to put a final lid on the murder of this extraordinary person.

The Norwegian Death protocol has also been forged, among other things stating that the late Mr. Johannessen had been buried (i.e. not cremated), that he had no children, and that he did not leave behind any testamentary documents.

Approximately a week before a hearing was to take place in Oslo City Court in December 2007, I summoned Ms. Sellæg as a witness. She was to reveal information about Mr. Johannessen, her life with him and especially about her last days together with him. On December 7 2007 Ms. Sellæg wrote an e-mail to me indicating that she wanted to talk about the case and in particular about the fact that she had been summoned. Since I didn't respond immediately she called me an hour later. She was in distress and the following conversation took place:

0:01:17:

HJB: How do you feel about this?

ALS: Oh dear, what if, oh, I get so nervous that I am about to faint.

0:02:24:

HJB: He² should have been put in jail long time ago.

ALS: Yes, yes, I do understand, ehe, I have some, and I know everything, eh, I have been informed about a lot, but you know I don't dare to say much. I have received death threats. That was the reason why I moved up north...so dear Good, I am afraid of getting a bullet in the neck.

To wrap this up:

We have medical documents stating that Mr. Johannessen was killed. We have documents proving that Swedish and Norwegian authorities have forged important official documents in regards to Mr. Johannessens death. We have voice recordings, e-mails and other documents proving that Ms. Sellæg is living under a constant threat, that she is afraid of being executed, thus fearing for her life. We have documents proving that Ms. Sellæg has been forced to silence, and who the perpetrator is. Furthermore we have voice recordings proving that Ms. Sellæg was not alone (as claimed) with Mr. Johannessen at the time he got sick, a few days before he passed away.

The problem we are experiencing is that the relevant authorities in Sweden and Norway as well as in Monaco are spending huge funds in different actions attempting to silence me in order to put a final lid on the case, instead of investigating this brutal murder and prosecute the perpetrators. To put it in other words: I have provided Swedish authorities with enough information and evidence to locate and prosecute the perpetrators, but instead of serving and protecting the people, officials with these authorities turns around and use all power available to act in accordance with some high-rank order which instructs them to defy and scorn the law for some higher private purpose.

In this picture the hunt for Mr. Assange seems to have points of resemblance to this case.

One have to admit that the minister of Justice as well as the Swedish prosecuting authorities lately have been sending eerie signals to the man in the street when officially accepting the royal family and their closest friends openly entering into corruption, while the rest of its citizens are forced to obey the law.

It doesn't really get any better when the same authorities accepts orders from warring western governments to take down one of their "opponents", which seems to be the case in this Assange-matter.

By this I petition, yet again, the Minister of Justice as well as the Director General of Public Prosecution to initiate investigation on the murder of the late Einar Riis Johannessen.

Previous correspondence in this matter:

November 29 2007, December 3 2007, December 12 2007, March 11 2008, March 28 2008, October 6 2008 (bribing Swedish judges), October 6 2008 (war crimes and terrorism).

Finally I would like to underline that we are holding both of you personally liable for any consequences your misconduct has caused in this matter.
